

# **Privacy Policy of PCI Nederland**

This Privacy Policy applies to all the use of the website www.pci.nl and any other websites and/or applications of and agreements with PCI Nederland B.V., New Yorkstraat 66, 1175 RD Lijnden, hereinafter referred to as "PCI."

By using this website, you agree to the terms of this Privacy Policy. Each time you provide information through this site, you consent to the collection, use, and disclosure of that information in accordance with this Privacy Policy.

## 1. Purposes of Use

To provide you with the best possible service, PCI may need to store your (personal) data in certain cases. PCI uses your data for:

- The execution of agreements, transactions, and services.
- Relationship management.
- Product and service development.
- Determining strategy and policy.
- Monitoring and analyzing the use of its website.

And, if necessary, detecting unlawful conduct related to PCI, its relationships, and its employees.

When visiting the website, PCI may collect personal data. Like many websites, this site collects information from visitors actively and passively by asking specific questions and allowing visitors to communicate with us directly via email. The information provided may contain personal data (i.e., information directly attributable to you, such as your name, address, email address, phone number, etc.). ## 2. Disclosure to Third Parties

## 3. Access and Correction

You can access the personal information PCI processes about you. You may ask PCI for access to the data stored about you. If the information is incorrect, you can request to have it corrected or supplemented. You can also request PCI to delete this data. All of this can be done by contacting us at marketing@pci.nl.

## 4. Data Security

We protect your data using all reasonable means, but due to the public and open nature of the internet, we cannot guarantee 100% security of information transmission via the internet.



## 5. Google Analytics

To track how users use the website and the effectiveness of our Google AdWords advertisements, PCI uses Google Analytics. The information obtained, including your computer's IP address, is stored by Google on servers in the United States. Google uses this information to track how our website is used, provide us with reports about the website, and offer advertisers information about the effectiveness of their campaigns. PCI has no control over this. Google is not allowed by PCI to use the analytical information obtained for other Google services.

# 9. Cookies
